# Summer Sponsoring Splash Details

## SPLASH PACK FULFILLMENT

Splash Packs will be shipped weekly as they are earned.

ESTIMATED shipping dates are:

- TUESDAYS: 6/5, 6/12, 6/19, 6/26, 7/3

New petPro qualifiers are identified each week, one business day before scheduled ship days (typically on Mondays). petPro must meet the \$150 PV requirement the Sunday before that Monday.

- EX: A new petPro enrolls on 6/1 and by midnight of 6/3 has 150pv. Their Splash Pack will ship on approximately 6/5
- EX: A new petPro enrolls on 6/1 and has \$150 PV as of midnight of 6/17. Their Splash Pack will ship on approximately 6/19.

Only 1 Free Splash Pack per qualifying petPro can be earned.

## WHO CAN EARN A SPLASH PACK?

Any petPro who enrolls during the month of June with any of the available enrollment options and achieves \$150 in PV by the end of June.

## SPLASH POOL / SHARE DETAILS

### How Do I Earn Shares?

When a petPro sponsors 5 petPros who have \$150 or more in PV during the month of June, they earn a share in the Splash Pool.

No limit to the number of shares a petPro can earn.

When a petPro has 4 sets of 5 qualifying petPros (20 total qualifying new petPros), you receive a bonus share, totaling 5 shares instead of 4.

- 1 share for every 5 qualifying personally enrolled petPros during the month of June.  
Example: 25 qualifying petPros = 6 total shares (5 for the first 20 + 1 more share for the next 5)

### How Much is a Share Worth?

The Splash Pool will launch with a bonus pool of \$5,000 to be divided amongst all shareholders.

- Example: if 10 shares are distributed, each share has a value of \$500
- Example: if 20 shares are distributed, each share has a value of \$250

If the total number of shares distributed exceeds 20, the Splash Pool amount will be increased to a guaranteed a minimum share value of \$250.

- Example: if there are 25 shares distributed, each share has a value of \$250, increasing the total value of the Share Pool to \$6,250

### How is a Share Paid?

Shares will be paid into qualifying petPro's pawPay accounts at or around the same time as end of month commissions are paid (approximately July 8 th ).

- Share payments will be noted separately from commission payments, Fast Start bonuses and pawUP rewards.

Policy Compliance: Shareholder accounts will be audited for policy violations before shares are confirmed and paid. (see policy notifications below)

## POLICY NOTIFICATIONS:

As noted in policy 22 of the Policies and Procedures, bonus buying is not permitted. Per policy 27, pawTree reserves the right to take back bonuses paid, or incentive rewards earned on cancelled orders, including but not limited to rewards earned on EZ Ship orders cancelled before their 3rd shipment cycle. Also, please note policy 23 regarding qualified new petPro enrollments. pawTree reserves the right to take back income and/or incentive rewards on cancelled or unverifiable petPro enrollments.
